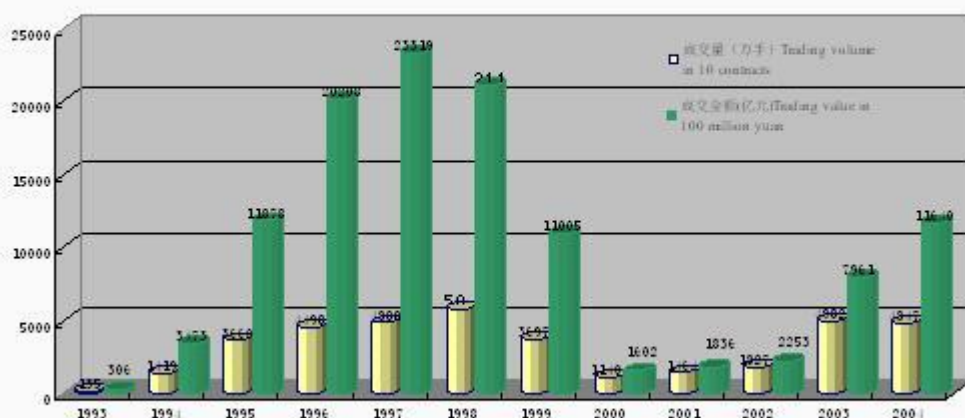

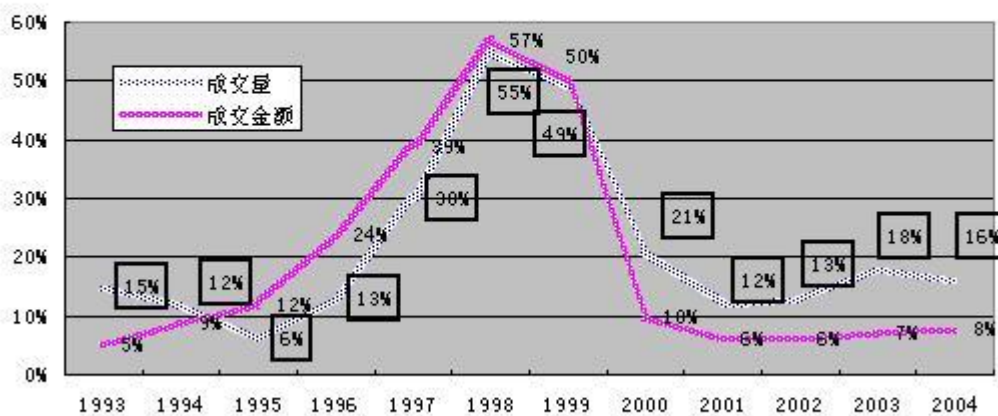
历年期货成交量、成交金额对比图

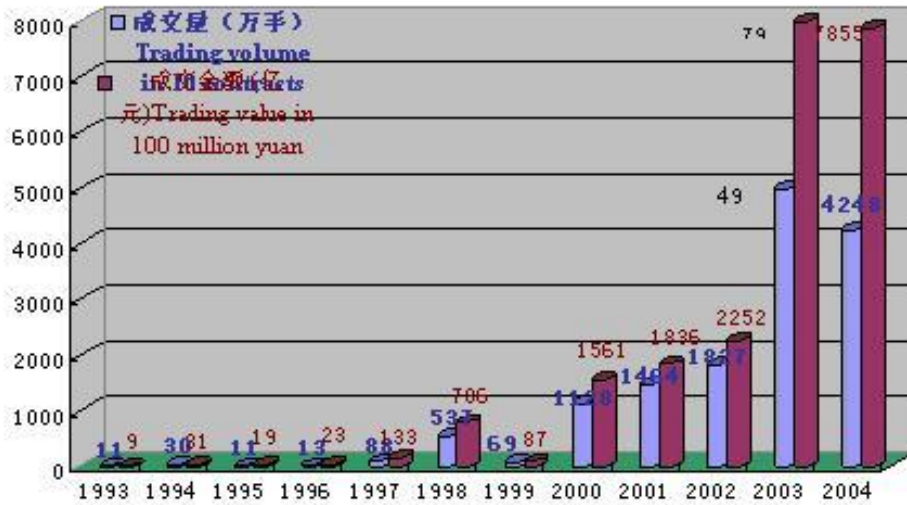
历年成交量、成交金额占全国市场份额图

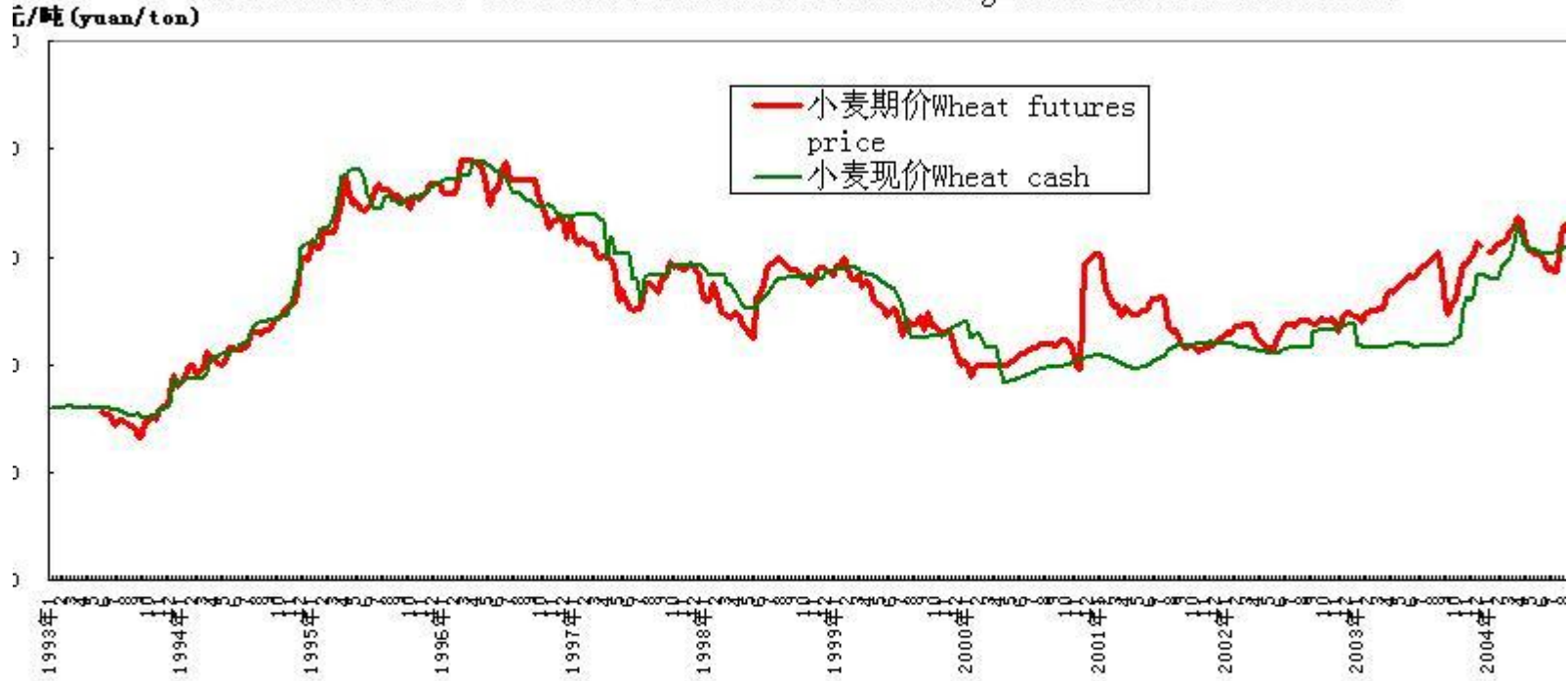
历年硬麦成交量、成交金额对比图

 Wheat Futures Prices of ZCE vs. Cash Prices of China Zhengzhou Grain Wholesale Market



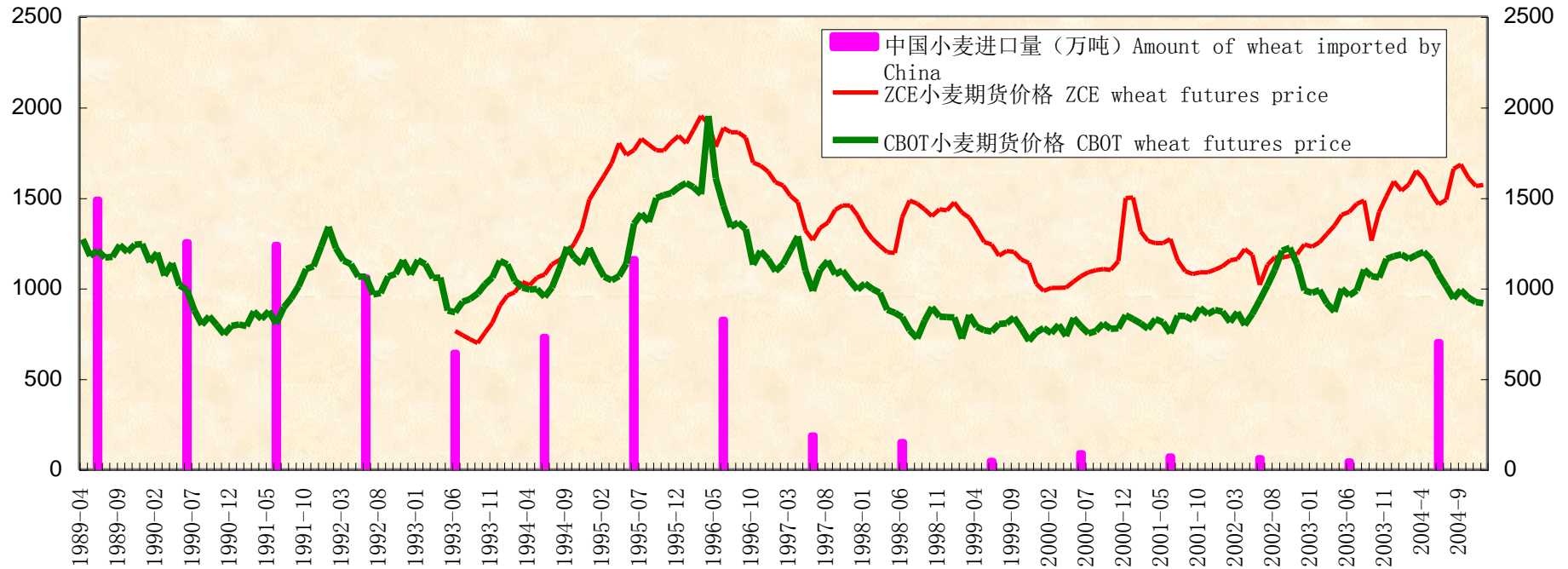

Cotton Futures Prices of ZCE vs. Cotton Futures Prices of NYBOT (元/吨)



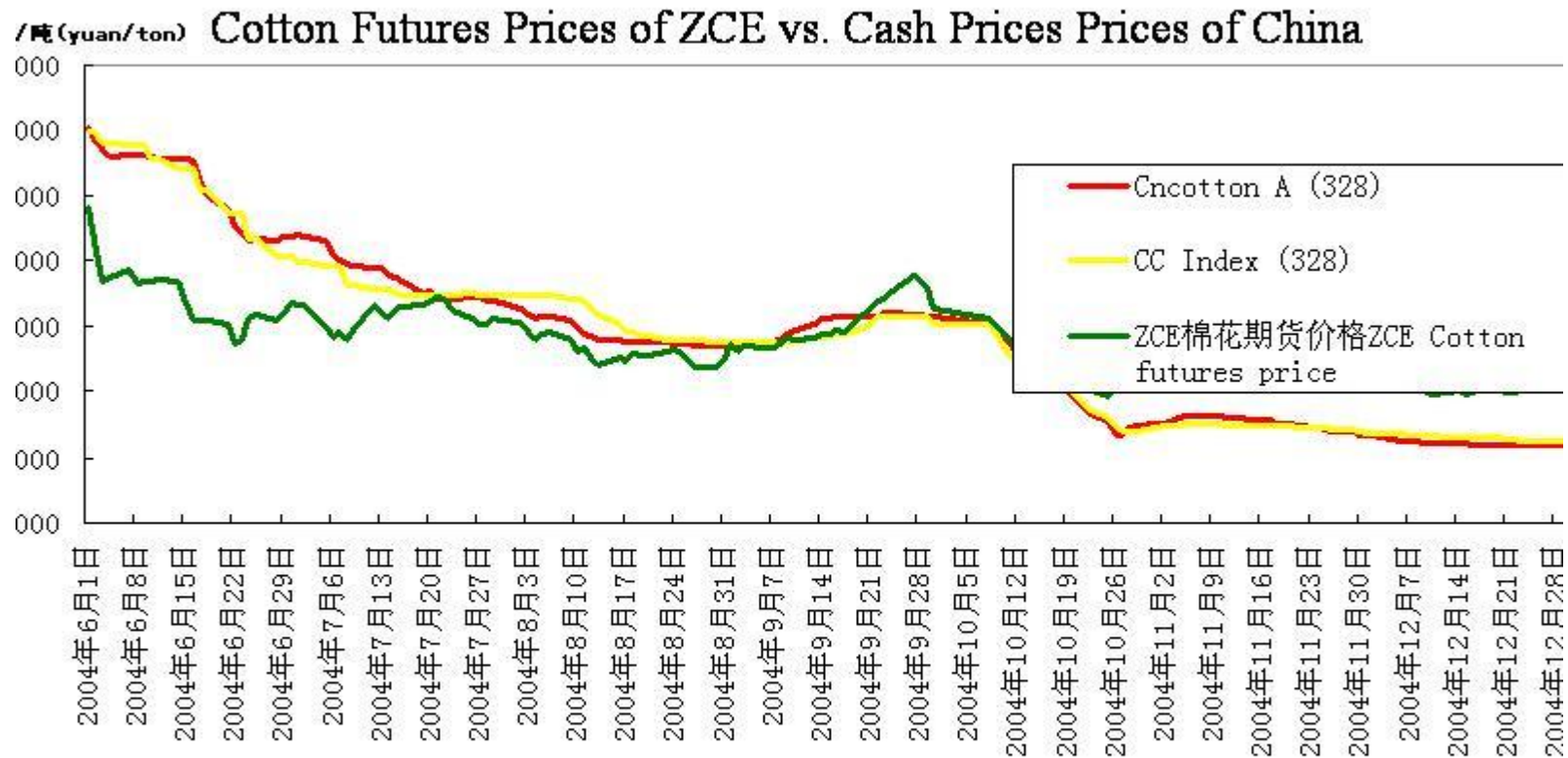
